All Program Presenters are to be current financial Triple H FM Members, sign an initial 'Three month Provisional Contract' & 'Triple H FM Operating Agreement' (attached) and provide Program Committee with recorded advertisement (or add that can be live-read), program bio for the Web and publicity information for promotion before contract is valid.
3. Only qualified Triple H Presenters, authorized by the Training Committee, are permitted to operate the studio panel and station equipment.
4. All Co-hosts are to be current financial HHH Members, sign '[Triple H Operating Agreement](#)' and agree to undertake the next available Triple H Induction Program.
5. A \$50 refundable deposit is payable for a security key to the building and \$10 for a copy of the studio
